What is the FAFSAWeb URL?

When is the FAFSA opening this year?

FAFSA opens Oct. 1, 2020. FAFSAWeb opens Sept. 15, 2020 so you can determine which Direct Admissions letter your students will be seeing when they login to Apply Idaho this year.

How do we sign up for a FAFSAWeb login?

Apply Idaho

Students go where to apply for Apply Idaho? Is it its own website?

I know Apply Idaho opens up October 1st, but for a school that has over 550 Seniors can it open up earlier?

Unfortunately, we won't be able to open Apply Idaho - Phase II (where students submit applications) prior to Oct. 1, 2020. It will open on Sept. 15 to allow students to create accounts and login to see which Direct Admissions Letter they received.

It was mentioned earlier that someone would provide a document ahead of time with the essay/supplemental questions that will be asked on Apply Idaho. When should we expect to see that document?

The Apply Idaho Essay Fact sheet is now available on Next Steps. Find it on the *Direct Admissions Initiation Resource page*.

How can we get a download of the letters to mail out if our district wants to do that?

Both English and Spanish version of this year's Direct Admission Letters can be found on the Next Steps Idaho *Direct Admissions Initiative Resource page*.

So just to verify, students can log into Apply Idaho on Sept. 15th to see their letter but the application portion (Phase II) doesn't actually open till October 1st? Is that correct?

Correct. Phase I of Apply Idaho opens on Sept. 15. This is when students can create and verify their accounts as well as view and download their Direct Admissions Letter. On Oct. 1 Phase II will open. This is when students will be able to submit applications to one or more of Idaho's public institutions including NNU and C of I for FREE.

Can students use Common app?

Yes, if the institution(s) your students are interested in attending are included on the Common app they can use that. Apply Idaho includes all public institutions in Idaho as well as Northwest Nazarene University and the College of Idaho. Students can us this application to apply to one or more for FREE.

Idaho Opportunity Scholarship

Any new information about whether or not SAT/ACT will be required for the Idaho Opportunity Scholarship?

We don't know yet. It's not required unless the applicant only holds a GED and no college credit.

What about adults who graduated from an ID high school or got their GED but have never attended college? Do they need to take a SAT? Can they even do that as a 30 or 40year old?

If a student graduated from an Idaho high school, we can use that GPA. If they only have a GED and no college classes and did not graduate from high school, they must have the ACT/SAT at this time. We need to discuss if there are alternatives.



Are we really asking someone who got a GED years ago to take the ACT/SAT?

Unfortunately, the rules that govern the scholarship (that are set by the legislature) require an ACT/SAT if a student did not graduate high school and does not have any college credits and only a GED.

Do you anticipate the Legislature increasing funding for Idaho Opportunity Scholarship?

OSBE will not know the level of funding for the 2021-22 academic year until the 2021 Legislative Session.

Governor's Cup

Can the Governor's Cup Scholarship go towards a college out of state?

No, it can only go to eligible in-state institutions. Find out more about the Governor's Cup scholarship here.

How many students usually receive the Governor's cup scholarship?

Typically 25-35. The number of awards depends on how much funding they raise for the scholarship each year. They list their recipients at www.idahogovernorscup.org

They do not have to register, but if they do they will be able to participate in the scavenger hunt, download marketing materials from institutions and have follow-up conversations with those institutions they are interested in learning more about.

We will have all our public institutions (2 and 4 year) along with BYU-I, BBC, C of I and NNU. Those public insitutions with CTE programs will have reps attending.
